

Eclipse Technologies Inc. warrants forever all parts and mechanisms on the retractable door and window screen to be free of defects in material and workmanship. **This warranty expressly excludes the screen mesh.** This warranty is extended to the original purchaser, whose name appears on the warranty certificate, and is in effect at the location also shown on the warranty certificate. This warranty applies only to the residential installations (single family detached housing and detached duplex housing and condominium) and is not transferable to another party. The word "defect(s)" as used in this warranty, is defined as imperfections that impair the utility of the retractable door and window screen. Implied warranty of merchantability and fitness for a particular purpose, are limited to the terms of this warranty.

What we will do

Eclipse Technologies Inc. will repair or replace any part of the retractable door or window screen found to be defective in workmanship or material without charge to you as specified in the warranty.

What you must do

The retractable door or window screen must be properly measured and installed by a qualified Eclipse Technologies Inc. Dealer and cannot be altered in any way. You must have mailed in the attached warranty card.

How to obtain service

You must notify in writing the dealer from which the retractable door or window screen was purchased within 14 days after the circumstances arise and are discovered by the owner. You must provide a proof of purchase.

What is not covered

This warranty does not cover damage caused by misuse, abuse, scratching, corrosive atmosphere contaminates, lighting, windstorm, tornadoes or any other act of God, or other causes beyond the control of Eclipse Technologies Inc. Also not covered is the color change that takes place with the passage of time. In no event shall Eclipse Technologies Inc. be liable for any direct or indirect loss, consequential damage, or any other claims except as provided for in this warranty.

For life from the time of purchase this non-transferable warranty from Eclipse Technologies Inc. will cover any part of the unit that is defective under the terms of this warranty free of charge (excluding labor) on a prepaid basis. Screen mesh specifically excluded in this warranty. All nylon parts are covered under this warranty except for color fade.

All fasteners are covered under this warranty for corrosion only and will only be replaced on the basis of evidence of corrosion, not from drill/screw driver bit damage during installation or removal.
